

SIX TIX PACK CARD RULES

- Six Tix Pack Cards may be picked up starting October 31, 2015. Pass Office will be open on weekends 9 a.m.-5 p.m. starting October 31, 2015. Once ski season starts, the Pass office hours will be Monday-Tuesday 10 a.m.-4:30 p.m.; Wednesday-Thursday 10 a.m.-7 p.m.; Friday-Sunday 9 a.m.-7 p.m.
- YOU MUST HAVE PROPER IDENTIFICATION WITH YOU WHEN PICKING UP YOUR CARD.
- Six Tix Pack Cards will not be issued until all information provided on this application is verified by the Hidden Valley Season Pass Office staff.
- For everyone’s safety, all skiers and snowboarders must obey Your Responsibility Code and Hidden Valley’s area policies.
- Card is valid opening of season through the end of the 2015-2016 season or March 27, 2016.
- If your Six Tix Pack Card is lost or stolen, notify the Season Pass Office immediately.
- Replacement allowed one time only, at our discretion, at a charge of \$15.
- Please protect your Six Tix Pack Card as you would your cash or credit cards.

SIX TIX PACK CARD RELEASE AND WAIVER AGREEMENT

In consideration for a Super Seven Card for use of ski slopes, lifts, terrain areas, and other facilities related to downhill skiing/ snow boarding issued daily by Seven Springs Mountain Resort, Inc., d/b/a Hidden Valley Resort, its owners, officers, employees, agents, representatives, parents, and affiliates (hereinafter, “Hidden Valley”), I agree:

(1) that I understand that there is a risk of serious injury or death if I participate in skiing or snow boarding. It would be impractical to list all the risks. Some of the risks include, falls caused by bare spots, variations in surface and subsurface snow an ice conditions, variations in terrain and terrain area features (table tops, ramps, half-pipes, rails, etc.), bumps, moguls, stumps, rocks, other forms of forest growth and debris. Risks also include collisions with other persons, lift towers, poles, cables, snow making equipment, snowmobiles, grooming machines, fences, barriers, and other natural and man-made obstacles on and/or off of trails. Another risk is falls and collisions caused by the negligence of others, including Hidden Valley. I acknowledge that it is my responsibility to follow “Your Responsibility Code”, all rules regarding terrain park use, and all other instructions, rules and directions provided by Hidden Valley, and to exercise caution and remain in control while participating.

(2) to accept all risks, whether specifically listed in paragraph (1) above or not, which arise out of or are related to the use of my Six Tix Pack Card to ski or ride at Hidden Valley.

(3) that my Six Tix Pack Card may be suspended or revoked, without reimbursement to me, if I do not follow the rules, instructions and directions of Hidden Valley.

(4) to waive my right to bring any claims against Hidden Valley that arise out of or relate to my use of my Six Tix Pack Card to ski or ride at Hidden Valley, and to release Hidden Valley from liability for any such claims. This waiver and release includes, but is not limited to, claims based upon allegations of negligence on the part of Hidden Valley. I further agree that I will indemnify, hold harmless, and reimburse Hidden Valley for all losses (including attorneys’ fees and costs) from any claims brought by any persons or entities arising out of or relating to my use of my Six Tix Pack Card to ski or ride at Hidden Valley.

(5) that the terms of this Agreement shall be binding on my heirs, executors, administrators and assigns, and shall be governed by the laws of the Commonwealth of Pennsylvania. I agree that all disputes arising under this Agreement shall be litigated in the Court of Common Pleas of Somerset County, Pennsylvania.

(6) I grant Hidden Valley permission to use photographic and/or video images of me for the purpose of marketing, publicizing and promoting the resort operations. I waive any right to be compensated for the use of my image and release Hidden Valley from liability for any claims, where such claims arise out of or relate to Hidden Valley’s use of my image.

The Hidden Valley Six Tix Pack Cards are redeemable at all lift ticket outlets for six individual, all-day session, single day tickets. Only one area ticket per day may be redeemed at any time and cannot be combined with any additional discount, package, coupon offer or contracted rate. There are no “blackout” dates.

GENERAL RULES

1. The Six Tix Pack Card is non-transferable.
2. The Six Tix Pack Card may be re-loaded with additional purchased days of lift tickets: Adults - \$44 | Children (ages 6-11) - \$38
3. The Six Tix Pack Card is not a season pass. You must get a valid lift ticket.
4. Six Tix Pack Card is void at the end of the 2015-2016 ski season on March 27, 2016.
5. Hidden Valley reserves the right to refuse any application.
