Steven A. Osborne AND Sierah L. Caldwell, on or about the 12th day of February, 2021, at 3719 Blue Knob Road, Apartment B, Washington County, Ohio, aforesaid, did purposefully or knowingly, and when purpose or knowledge is sufficient culpability for the commission of an offense, engage in conduct that, if successful, would constitute or result in the offense of Murder in violation of 2903.02(A) & (D), to wit: the Defendant did purposely cause the death of another in violation of Ohio Revised Code §2923.02 / §2903.02(A), 2903.02(D), 2929.02(B), **Attempted Murder**, a felony of the first degree.

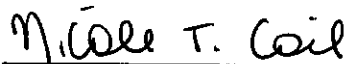
