City of Nashua - Board of Registrars

New Hampshire law requires that the Board of Registrars verify the checklist every ten years. Any person on the checklist who has not voted in the past four years (since April 1, 2017) must re-register to remain on the checklist. The Board of Registrars are sending notice letters to these voters at the address the voter provided when registering.

Qualified applicants who do not possess proof or who do not bring proof with them may still register if they sign an affidavit attesting to their qualifications for identity, age, and citizenship, and / or domicile.
