RELATIVE TO A BALLOT REFERENDUM CONCERNING SOCIAL **DISTRICTS WITHIN THE CITY OF NASHUA**

This resolution follows the procedure required by RSA 178:34 which states that if the operation of "social districts" is to be allowed in a city or town that the question be put to the voters of said city or town. If a majority of the voters vote "yes" on this question, social districts may be established and operated within Nashua in accordance with the statutory requirements, including RSA 178:35-37. If the ballot question passed, the Board of Aldermen would then take further legislative action to define the areas, days, and hours of the social district(s) and establish the necessary management and maintenance plans as required by state law.


